## I. What I Can Learn Time

- А. Bryce Dolan from the Clay County Medical Center and Dana Rickley will Present on the Community Health Assessment
  - a. Community Health Assessment was administered in 2024
    - i. Only 1.9% of Clay County residents responded, so CCMC is
      - looking for ways to improve this in the next survey (every 3 years)
  - b. Drug and alcohol use and domestic violence/mental health issues were all trends
  - c. CCMC is in the early stages of providinghuman traffic education and domestic violence resources
    - i. Courageous Conversations event? This is a possibility
  - d. We do have some of these resources in place, but they need to be better communicated

## II. *How I Can Contribute Time*

- A. YLinK Report: Raegann McDonald and Braylee Langvardt
  - a. Two different 5<sup>th</sup> guarter events were held at CCCHS in the last two months
- B. Report from Izzy Blackwood on National CADCA Convention in Washington, DC
  - a. This was the first time a Clay Center youth rep got to attend the conference
  - b. This conference focused more on mental health, and possible speakers were given to Lori to bring to Clav Center
  - c. Izzy also attended two training tracks on collegiate partnering (led by a University of Alabama coalition) and substance abuse and how they may or may not connect with mental health (correlation, but not necessarily causation)
  - d. Izzy also talked to senators Moran & Marshall and DEA agents on Capital Hill
  - e. Next week Izzy will be going to the state capital with the same group to continue these conversations in Topeka

- f. Izzy will also go back to D.C. in April for a leadership retreat and is looking to become a CADCA trainer
- g. Former CCCHS student Russell Spurlin is running the Wichita State chapter
- h. USD 379 is also looking at making YlinK a paid supplemental position next year for CCCHS and Wakefield
- C. Follow UP on Strong Sisters Courageous Conversation: Allie Martin
  - a. We had around 50-60 people attend
  - b. Speakers gave a wide variety of topics covered
  - c. Allie is looking to do a similar event next year if there is interest
  - d. Thanks goes to the Rex Theatre for letting us host the event for free and to Common Ground for offering up a place for daycare

  - a. This will be Saturday, April 12 from 8-12 (combined with the health fair)b. Bill Robinson will be there to help

      - 2. Will Clay County's specific data be shared? (Lori will check into this)
    - b. Lori has conducted an hour-long interview with this group, and we will hear soon if we have been selected (no charge to us if we are selected)
